The Community and Care in the Home Portfolio collaborates with clients of all ages within their communities by providing a continuum of inpatient, community, and home-based healthcare services. This in turn ensures that high-quality, patient-centred care is integrated and delivered, empowering clients to manage their health within their communities. The diverse services include:

Public Health & Priority Populations supports vulnerable groups through services like the Refugee Health and Wellbeing Service, which provides comprehensive care, and Community Youth and Family Services, which delivers health services to marginalized young people and their families.

South Eastern Centre Against Sexual Assault (SECASA) offers therapeutic interventions and crisis response for victims of sexual assault and family violence, while the **South East Public Health Unit (SEPHU)** collaborates with health departments and stakeholders to promote public health, disease prevention, and management.

Care in the Home enhances patient outcomes and promotes independence through services such as Hospital in the Home, which provides acute treatment at home to prevent hospital visits. The Community Assessment and Response Team (CART) allocates resources to those in greatest need, helping avoid emergency visits. Community Rehabilitation offers short-term rehabilitation to improve independence after medical events, and Residential in Reach supports clients and care providers in Residential Aged Care Facilities.

Community oversees and integrates areas to ensure high-quality, accessible healthcare services that support individuals to live well, stay well, and get well. This includes managing access to Monash Health's community-based services, providing specialist clinics and assessment tailored to meet the diverse needs of the community and coordinating services and support for individuals with disabilities and chronic diseases to enhance their quality of life and health outcomes.
